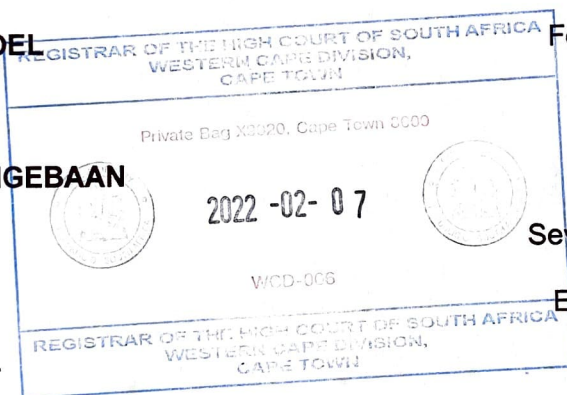

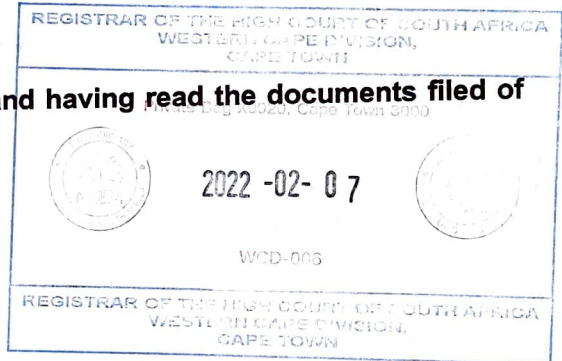

IT IS ORDERED:

1. That the Third, Fourth and Sixth Respondents are directed forthwith to discontinue any activities intended to give effect to or related to the seismic survey of the west and south-west coast of South Africa that commenced on or about ²⁷~~15~~ January 2022.
